5k RULES & GUIDELINES:

- 5k's in the City of Springboro can only be held in and around North Park, on the approved course (attached to this application) on the streets adjacent to North Park and can only occur on Saturdays or Sundays, between the hours of 8am 11am (does not include setup and tear down), unless a specific exemption is granted by the City Manager or held entirely on private property or at the Springboro Schools.
- Only one 5k can be held on this approved course per month. They will be scheduled on a first come, first served basis. This will help the City minimize the disruption to the surrounding neighborhood.
- 5k must have AT LEAST eight (8) volunteers out on the course to control runners at locations indicated on attached course map.
- The organizers will be provided signage from the City to indicate the intersections where the runners will make turns on the course. The event organizers are required to place the signs in the proper locations and are required to collect the signage and return them to the City after the event.
- 5k must supply event liability insurance acceptable to the City of Springboro, and insurance MUST be supplied to City as part of this application, before the event occurs.
- A Springboro Police Officer will be assigned to monitor the event, however the Police Officer may be called away to perform regular duties in case of emergency.
- If the event would require (or prefer) Police Department personnel, the event shall be charged a minimum of \$50 per hour for each officer required (or preferred), and a minimum charge of \$200 shall apply. This is not required to hold the event.
- Any music or announcements that are a part of the event WILL NOT commence before 8am and the sound from said music or announcements shall be controlled and shall not be heard outside of the North Park property.
- Any tents, bounce houses, etc., that are required to be anchored into the ground locations MUST be approved before the event occurs.
- Applicant is aware that North Park is a public park and the general public cannot be restricted in any way from their general use and enjoyment of the park. North Park is simply provided as a parking area for participants and/or staging area for the event.
